# A THREAT TO LIFE & WOMEN IN NEBRASKA



The abortion industry is circulating a ballot initiative seeking to create a right to abortion in the Nebraska Constitution, which would legalize abortion until birth. Abortion advocacy groups are currently collecting signatures and spending millions of dollars to confuse and mislead voters.

Women, children, and families in Nebraska deserve real love and support, not dangerous proposals that jeopardize the health and safety of women and end the lives of precious baby boys and girls.



# WHAT'S IN THE PRO-ABORTION INITIATIVE?

### **Broad Exceptions**

The initiative contains a vague "health exception" determined entirely by the abortionist. Exceptions could include non-physical factors, such as emotional, spiritual, and financial health. This opens the door to abortions up until birth.

#### **Late-Term Abortions**

Viability is defined as being based solely on the abortionist's judgment and would allow abortions in the second and third trimesters. Babies feel pain before viability—at 15 weeks or earlier. Babies who can experience pain would be subjected to painful late-term abortions.

#### No Parental Consent

The initiative creates a fundamental right to abortion for "all persons," including children and minors. This would eliminate our state's parental consent law, meaning parents will not have any ability to consent or even know if their child seeks or obtains an abortion.

#### **Protections Eliminated**

A "fundamental right to abortion without interference from the state" puts existing medical safeguards that protect the health and safety of women at risk of being eliminated. This includes informed consent statutes and requirements that the abortion be performed in person and by a licensed doctor.

"Except when a woman seeks an abortion necessitated by a medical emergency or when the pregnancy results from sexual assault or incest, unborn children shall be protected[1] from abortion[2] in the second and third trimesters."[3][4]

- [1] Protect women, children, and babies who can feel pain while allowing Nebraska to continue to grow a culture of life.
- [2] Establish a minimum level of protection for preborn babies in the second and third trimesters, and allow for greater protections in the future.

#### THE LANGUAGE:

"All persons shall have a fundamental right to abortion until fetal viability,<sup>[1]</sup> or when needed to protect the life or health<sup>[2]</sup> of the pregnant patient, without interference<sup>[3]</sup> from the state<sup>[4]</sup> or its political subdivisions. Fetal viability means the point in pregnancy when, in the professional judgment of the patient's treating health care practitioner,<sup>[5]</sup> there is a significant likelihood of the fetus' sustained survival outside the uterus without the application of extraordinary medical measures."

Supported by national abortion activist groups, Planned Parenthood, and the ACLU of Nebraska.

- [1] Allow late-term abortion on babies who can feel pain in the second and third trimesters.
- [2] Abortion throughout pregnancy: "Health" is determined solely by the abortionist and can **include non-medical factors** such as mental, spiritual, financial, or familial health.
- [3] Enable abusers and traffickers by eliminating parental notification requirements.
- [4] "Without interference from the state" eliminates all laws regulating the abortion industry, including women's health and safety requirements.
- [5] "Viability" is determined solely by the abortionist and would not include any baby who may need "extraordinary medical measures," such as a stay in the NICU.
